Major In Venue Promotion (Venue Jackpot) Terms And Conditions

Promotional Period

1st day of every calendar Month – Last day of every calendar Month

Venue Jackpot Prize Pool – Terms and Conditions

- 1. Information on how to enter and prizes forms part of these terms and conditions.
- 2. The promotion is open to Jackpot Club members 18 years of age and over.
- 3. Non-members may participate by joining Jackpot Club at any time during the promotion.
- 4. The Venue Jackpot Prize Pool drawing mechanism will process entry data every five minutes. The approved drawing engine (approval 987) will increment current meter from the base value until the current value equals or exceeds random threshold winning value.
- 5. J-card members can participate in the individual promotional prize draw by:
 - a) Inserting a Jackpot Club Card into gaming loyalty reader adjacent gaming machine and wagering at least one cent on the Electronic Gaming Machine

Conditions of entry - Gaming:

- Jackpot Venue is participating in Venue Jackpot Prize Pool
- Anonymous or Partially enrolled membership cards are excluded
- Card holder agreed to participate in Gaming Rewards Scheme (default)
- At least one cent has been wagered on EGM (Turnover meter incremented)
- 6. The prize pool range for each individual prize draw is between \$15 and \$50.
- 7. For each prize draw, the approved Random Number Generator (RNG) (Approval 987) will select a randomised pre-determined winning value between \$15 and \$50
- 8. The Venue Jackpot prize is specific to a venue and not linked in any way to another venue
- 9. The Average Monthly prizes awarded per venue is based on the SUM of a venue's Total EGM incremental Turnover multiplied by a rate determined by a venue. Each participating venue's prize pool begins on the first day of each calendar month and concludes on the last day of each calendar month.

- 12. Once the pre-determined value is reached, the approved electronic drawing engine (approval 987) will Randomize card holders evenly (venue specific) I.e. A card holder with 1 eligible entry has equal chance as a card holder with 1000 entries
- 13. Winners will be notified of their prize instantly via one or more of the following mechanisms:
 - a. An in-venue audio announcement over PA System
 - b. A message alert on their Jackpot Gaming reader stating Venue Jackpot Winner See Cashier
 - c. A message alert for gaming staff displayed on Cashier PC

d. A message alert each time a card with unclaimed prize is inserted into a participating venues jackpot reader

- e. Unclaimed prizes displayed on 'Ticker' below Mystery Points Pool Odometers
- f. Contact via phone by the Venue in which the Jackpot has been won
- 14. The prize value is awarded to the J-Card via gaming cashier PC at any participating Jackpot Venue
- 15. All prize winners have 3 months from the completion of the promotional period to collect their promotional points
- 16. Winning a prize will not disqualify a J card holder from the opportunity to win additional prizes
- 17. The minimum return to player on electronic gaming machines in the state of South Australia is 87.5%
